BACKGROUND

The Berkshire, Buckinghamshire and Oxfordshire Wildlife Trust (BBOWT) is the only charity working to safeguard wildlife and natural landscapes across the three counties. Founded in 1959 by a small group of volunteers, we now have more than 27,000 memberships and 1,700 volunteers. We own or manage more than 80 nature reserves and work in partnership on conservation projects with local communities, businesses, landowners and local authorities. Each year around 12,000 schoolchildren visit our four education centres. We have strong finances, with an annual turnover of £6 million and we're proud of our highly effective and dedicated team of 150 staff.

BBOWT is part of a national network of 46 Wildlife Trusts, which means our work has a bigger impact, making a difference for wildlife beyond our three counties.

Our 'Wilder' plan for 2021-2026 sets one simple overarching aim: to create more nature everywhere. To do this, we need to inspire people to take action and do all we can to restore wilder landscapes.

Our three main goals are to:

- Put nature into recovery
- Empower people to act for nature
- Secure our future

JOB PURPOSE

The Head of Landscape Recovery will lead the delivery of projects in landscapes beyond our nature reserves, that support BBOWT's ambition to bring about nature's recovery. The role is responsible for all operational aspects of developing and delivering conservation projects, targeting priority areas within the Nature Recovery Network. This includes building appropriate expertise and team structure and developing new mission aligned projects and partnerships with key stakeholders. Success will be measured by evidence-based and positive outcomes for wildlife.

- Identifying innovative funding opportunities, such as natural capital investment.
- Developing new projects and partnerships, which use traditional grants and innovative forms of natural capital investment.
- Supporting the delivery of the Land Advice Service, through your team's capacity to deliver paid for pieces of work which support more sustainable and wildlife friendly land management practices on agricultural land.
- Working with the Policy, Planning and Advocacy team to negotiate conservation projects that address emerging Local Planning Authorities' climate and biodiversity commitments.
- Working with the Ecology team to jointly lead the development of best-practice monitoring and evaluation for all projects, to ensure BBOWT's effectiveness in supporting the delivery of enhanced wildlife and natural capital improvements.
- Representing BBOWT on key conservation and farming issues at county, regional and where appropriate, national level.

- Active member of the Operational Leadership Group, ensuring the delivery of the 5
