I'm delighted to invite you to our 64th AGM, at Didcot Civic Hall. You're welcome from 9:30 for coffee and to browse the pop-up shop featuring sustainable gifts from our Visitor Centre shops. MINUTES

Present 63 members attended the meeting (42 in person and 21 online)

Chair George Levvy (GL)

GL introduced Zoe Hancock (ZH), Honorary Treasurer and Estelle Bailey (EB), Chief Executive

GL noted that this year's AGM was being held hybrid both in person and online and the success of the format of the meeting will be reviewed for next year.

Members had been asked to vote ahead of the meeting via proxy. 42 proxy votes had been submitted. All items that are required to be 'proposed' and seconded' will be proposed by GL and seconded by 7H

There was a quorum present at the AGM.

2. MINUTES OF THE 62nd ANNUAL GENERAL MEETING, held on 14 October 2023

Proxy votes for the 62nd Annual General Meeting held on Saturday 14 October 2023 were as follows: **42** proxies provided, **39** FOR, **0** AGAINST, **3** ABSTAINING APPROVAL

The minutes of 62nd AGM held on 14th October 2023 were **APPROVED** as a true record of the proceedings and were signed by GL.

Matters arising: There were no matters arising surrounding the 2023 minutes.

3. REPORT OF THE CHIEF EXECUTIVE

The CEO presented an impact report video of the activities and achievements of the last financial year. BBOWT had a challenging year due to the cost-of-living crisis but with members support and the significant amount of work undertaken by Volunteers, BBOWT continue to work hard towards its vision of more nature everywhere for everyone across the 3 counties.

Highlights included:

- BBOWT celebrates its 65th anniversary next year, building on the legacy of its early days, when it was volunteer run with minimal resources but achieved significant impact.
- Today, BBOWT has grown to 150 staff with an £8M turnover, still rooted in ecology, science, and evidence based land management of reserves.
- BBOWT has developed a comprehensive toolkit for addressing the nature and climate crisis, including planning, policy, public affairs, education, community engagement, partnerships with farms, landscape scale projects, Future Nature Consultancy, BHG/Green Finance, and more.
- Growing recognition from people, businesses, councils, and farmers underscores the importance of nature and climate health, and BBOWT has a strong platform for building resilience.
- Together with the Wildlife Trusts, BBOWT is part of a powerful movement for environmental change.
- This year has been remarkable, with membership reaching its highest level, plus significant progress in community initiatives, farming partnerships, and through our Future Nature Consultancy.
- A strategic review has been ongoing to guide BBOWT's future.
- Community and farmer clusters have strengthened, supporting larger, more connected conservations project, such as the reconnection of Bernwood, Otmoor and Ray.

• Launched last year, the Nature Recovery Fund aims to raise £3M over 3 years and has already reached £500K. Members were thanked for their contributions, and a brief animation of the Nature Recovery Fund was shown.

EB expressed heartfelt thanks to all Trustees, Staff and Volunteers for their hard work and dedication, as well as to members for their generous contributions and support over the past year.

4. REPORT OF THE BOARD OF TRUSTEES

GL reported that the board of trustees continue to oversee the financial and strategic management of BBOWT, monitoring risk, and ensuring that all policies and procedures are compliant and complied with. There are a number of standard items which must be reviewed and addressed over the course of a year which were shown during the presentation. The Board meets quarterly to hear from the Chief Executive and Director Team. Outside these meetings there are one or two strategy days. There are a number of trustee-led committees who also meet regularly and report into the board including Finance & Audit Committee, Governance & Nominations Committee and H&S Committee.

Key discussions this year have been reviewing and reflecting on the current strategy Wilder for More Nature Everywhere 2021-26 which is now just beyond its halfway point with most of the objectives being on track.

Key highlights:

Goal 1: 30% of land well-managed for nature

- Purchase of Ludgershall Meadows in 2021
- Completion of Water Environment Grant at Chimney Meadows Nature Reserve.

Ludgershall Meadows and Old Duxford (part of Chimney Meadows) have now been registered at Biodiversity Net Gain sites.

Goal 2: Empower people to take action for nature

There has been real growth in community engagement and the Next Door Nature programme, funded by the National Lottery Heritage Fund, which enabled work with several urban communities in Slough and Reading.

Goal 3: Secure our future

The Nature Recovery Fund, Meles Giving Circle and Legacy Society have all been launched in the last two years which help to ensure fundraising is aligned with strategic priorities. Equality, equity, diversity, and inclusion are also being embedded into all levels of the organisation.

BBOWT is currently reviewing what 2030 might look like, which will serve as the focus for strategic discussions at the board level.

GL expressed gratitude to the trustees for their contributions to the board, as well as to the BBOWT staff and volunteers. He emphasised how fortunate the organisation is to have such dedicated individuals and acknowledged the significant impact of their contributions.

5. FINANCIAL REPORT FOR THE YEAR ENDING 31 MARCH 2024

ZH expressed thanks to Helen Belcher, Finance & Strategic Operations Director, and her team for all their hard work in producing the accounts.

ZH presented information on the Annual Accounts, noting the key figures. Overall BBOWT's income for the 2023/24 year was £8.7M, an improvement on £6.9M last year. There had been

an increase in legacies of over £300K and a significant increase in income from Habitat Banking and Future Nature.

Membership income was £3.2M an increase from last year even with the difficulties being faced with the cost-of-living issues, etc. Numbers of members also continues to raise with a new high of 29,849 as at 31.03.24.

Total expenditure for the year was £8.3M. Of this approximately £5.3M was allocated to charitable activities from both unrestricted and restricted funds. Additionally, £1.5M was spent on fundraising activities, primarily supporting the membership programme. Other costs included expenses related to generating income from our cafes and shops. It has been another challenging year due to rising inflation; however, as conditions begin to stabilize, we hope to plan with greater certainty moving forward.

ZH reported on expenditure related to charitable activities, noting that £2M was spent on managing nature reserves and approximately £1.5M on education and awareness initiatives. Additionally, around £1M was allocated to projects and activities aimed at caring for the wider countryside.

The balance sheet continues to be in a good financial position with £6.9M in cash and investments some of which relates to restricted funds and so is not available for general use. Approx £0.5M is being held for future land acquisition to protect and enhance land in our counties.

The trustees have set a free reserves policy to hold at between 3-6 months of free reserves which gives protection in the event of major changes to plans which have been useful during recent years with the challenges of Covid and inflation. Current forecasts show us staying within the set policy, and on a slightly upwards trend.

ZH gave an update on Biodiversity Net Gain (BNG) and Future Nature (consultancy arm of BBOWT) two new and growing income streams.

No finance questions had been received ahead of the meeting. There had been an opportunity for members to put any finance specific questions forward prior to the meeting.

There was a further opportunity for members to put questions to the panel, via the Q&A function, but none were received.

7. Election of Trustees

The Governance & Nominations Committee had recommended to the Board that the following nominations should go forward to the AGM:

Natalie Ganpatsingh and Gregory Webster's term extensions were inadvertently omitted from last year's AGM. As a result, they were co-opted by the board for a year, pending approval of their term extension at this year's AGM. The Board further recommended George Levvy, Drew Bennellick and Miles Evans, as continuing Trustees, for a further 4 year period.

The Governance & Nominations Committee had met to consider and lead the process of recruiting new Trustees to the Board. After a process of application and interview, the Governance & Nominations Committee recommended Amy Padfield, Sam Burgh, Subash Ludhra and Simon Dickson as new trustees and short biographies of each were included in the AGM papers.

Jolyon Austin (Chair of Governance & Nominations Committee) introduced three of the new trustees and conducted short interviews around their passion for wildlife and what skills and value they hoped to bring to the BBOWT Board of Trustees.

There were three Honorary Vice Presidents: Dr Robin Buxton, Audrey, Lady Wood, and Professor Sir Dieter Helm, up for re-election this year. All three have been fundamental to the success of BBOWT for many years, and all three continue to support the organisation. All three have indicated their willingness to continue and they were recommended to the membership for their reappointment.

There were two trustees retiring this year – Graeme Thompson and Frances Brindle.

The Chair gave a heartfelt thank you and best wishes to two long serving trustees, whose tenure on the board concludes at the AGM. Graeme Thompson has served as Honorary Treasurer and Chair of the Finance & Audit Committee, while Frances Brindle been the Vice-Chair of the Board of Trustees and our fundraising and marketing lead for many years. They were both acknowledged for the considerable time and expertise they have dedicated to BBOWT and were wished well in their future endeavours.

8. **Questions/Any Other Business**

Members had been asked for questions, to be received 1 week prior to the AGM, to allow for them to be answered fully. One question had been submitted in advance, and others taken from the floor during the AGM:

Question	Response
Please can volunteers have training in using social media correctly?	The Policy Team will consider running a session for members and volunteers on how they could support BBOWT campaigns.
The Complaints Log is reviewed at Board Level, but there is a tendency for charity leadership to overlook the positive feedback or take the plaudits for granted. It would be good to know that the plaudits are taken as seriously as the complaints.	Thank you! When positive feedback comes in, there is a process to make sure it is recorded and fed back both to members of the BBOWT Team who did the good work and BBOWT's leadership.
Wokingham Council appeared to be absent on the Nature Recovery projects and there have been concerns around their mowing of verges — has BBOWT made any progressing in trying to persuade Wokingham Borough Council to pay more attention to conservation matters?	There are three Local Nature Partnerships across the three counties. Wokingham Borough are an active member of the Berkshire LNP. They point out that they are under financial and resource pressure, so (for example) BBOWT have highlighted that they could save money by not mowing the verges. We are working on it and building the relationship, but there is still work to be done in getting this translated on the ground.
Question around planning applications: in light of government changes and the streamlined planning system, will BBOWT be busier and will the government be listening to wildlife charities?	BBOWT are aware of the government's targets for new homes and although we do not know where they will go we can assume a lot will be built within the 3 counties.
	There is the National Policy Framework and legislation changes coming within the planning system. We will work to encourage the right changes in the right places - e.g. we will support a solar farm in the right place, but we may oppose one if the harm to nature will outweigh the benefits of renewable energy.
	We do expect there to be more planning work for BBOWT to deal with, and so we will try and be a bit more strategic with our approach with local planning within authorities.
Team Wilder and funding for local nature project/rough around the edges project — are there any more plans for this kind of work to be done?	In relation to Team Wilder, the current strategy is based around people being one of our major pillars of activity and will remain so. We are now looking into the future to look at how we can fund this. As well as continuing with the community-focused projects, we will be putting more unrestricted income into staff posts to support this to support our local communities better to reflect and try and reach people we are not currently reaching. This is vitally important for the future of nature.

Additionally, the Board seems very impressive – what are we doing to make our board more diverse?

In terms of board diversity, the board are at the beginning of a process which they are taking seriously. They have recently agreed to create an Equity Equality Diversity Inclusion & Belonging (EEDIB) subcommittee which will be chaired by Amy Padfield (Trustee) who has a lot of experience in this field). She will be supported by Becky Hall, BBOWT's People Director.
